Specific Questions | Installation of Floor Boards/Tiles

To prevent the transmission of noise between apartments all flooring installations must include an acoustic underlay that complies with a noise/impact isolation product equal or better than an **L_{n,w+Ci} rating of 47** or it's approximate equivalent (**AAAC start rating of 5**).



Certification that the insulation meets the above standard must be provided by the insulation manufacturer in the form of a letter confirming that the insulation meets the above standard by a product specification sheet or certification from an acoustic engineer.

An application for flooring will NOT be considered unless the appropriate certification is supplied.

Have you provided confirmation from the insulation manufacturer that the acoustic underlay adheres to the building's acoustic standards as stated above?
